- On completion, you may advertise either of the following:
 - Participant has received a certificate of completion in the area of elder law issued by the Institute of Continuing Legal Education
 - Participant has completed the Institute of Continuing Legal Education's Elder Law Certificate Program and received a certificate of completion

How often is the certificate program revised/updated?

- ICLE will alert customers if content is affected by changes to the law and make updates as needed to reflect those changes
