## **Michigan Courts 101**

This handy chart, adapted from the seminar materials, provides an at-a-glance view of Michigan's trial court system. It outlines each court's subject-matter jurisdiction and monetary thresholds, initial pleading requirements for plaintiffs and defendants, and applicable discovery procedures.

Circuit Court	All civil cases where the amount in controversy is \$25,000 or higher and felony criminal cases.*	Plaintiff files a summons and complaint (and demand for jury trial if desired) with the court to start the case. Plaintiff serves defendant with the summons and complaint.	Defendant's responsive pleading is due 21 days after service of the complaint in person or 28 days after service by mail. MCR 2.108.	Plaintiff must serve initial disclosures within 14 days after the answer is filed. MCR 2.302(A)(5)(b). Defendant must serve initial disclosures within 14 days after the opposing party's disclosures are due or 28 days after filing the answer, whichever is later. Id. The discovery process is governed by subchapter 2.300 of the Michigan Court Rules.
Business Court (part of Circuit Court)	The business court is a specialized docket for business and commercial disputes within the circuit court. MCL 600.8031 et seq.	See circuit court information. When possible, business court cases should be filed electronically and at the face of the pleading indicate why the matter is appropriate for the business court. MCR 2.112(O).	See circuit court information.	See circuit court information.
Circuit Court: Family Divisions	The family division of the circuit court has sole and exclusive jurisdiction to hear domestic cases such as divorce, custody, child support, and paternity. MCL 600.1021.	In most domestic cases, a summons and complaint (SCAO form MC 01) must be filed and served on defendant, and, if necessary, a confidential case inventory (SCAO form MC 21) must be filed with the clerk. Plaintiffs may also need a record of divorce, verified statement if minor children, UCCJEA affidavit, and ex parte orders if applicable. Be sure to review local court rules and county court websites as local practice varies widely.	Defendants must prepare and serve responsive pleadings, including a notice of appearance, answer to the complaint, and counterclaim (if applicable). Objections to ex parte orders, if applicable, must be filed within 14 days of service.	Discovery in domestic relations cases follows circuit court discovery rules, except that parties must exchange a domestic relations verified financial information form (SCAO form CC 320). The form must be served on the opposing party within 28 days of the filing of defendant's responsive pleading.
Circuit Court: Criminal Divisions	Misdemeanor and felony cases.	Cases are initiated by the prosecutor charging defendant.	Defense counsel enters an appearance, and defendant enters plea at arraignment.	Discovery in criminal proceedings is covered by subchapter 6.200 of the Michigan Court Rules.
Probate Court	Guardianships and conservatorships, administration of trusts and estates, orders for the treatment of developmentally disabled or mentally ill individuals.	Proceedings are initiated by filing the appropriate application or petition. Civil actions follow traditional circuit court pleadings.  Notice of hearing must be served on all interested parties.	Interested parties may file a number of responsive pleadings, including objections to petitions, answers to the complaint, and appropriate motions.	Discovery in probate court follows circuit court rules unless there is a specific probate court rule that differs. MCR 5.131. Any interested person in a probate proceeding is considered a party for the purpose of applying discovery rules. Mandatory disclosures under MCR 2.302(A) may be required under certain circumstances. MCR 5.131(B).
